

Product and Price Information

For access to the hydrogen storage Epe H2 operated by RWE Gas Storage West GmbH (as follows RGSW)

A. Storage products

I. Overview of storage products

- 1. RGSW offers the following storage products:
 - firm storage bundle
 - firm unbundled storage capacities
 - · interruptible unbundled storage capacities

Storage products can be combined.

2. The booking period is a calendar year by default. Notwithstanding this, multi-year/long-term booking periods and booking periods less than one year are also possible.

II. Storage products, firm

With respect to the products "firm storage bundle" and "firm unbundled storage capacities", the storage capacity shall be provided by RGSW on a firm basis subject to other provisions in the General Terms and Conditions.

- (1) Firm storage bundle as standard product
 - 1.1 The "firm storage bundle" is the standard product and shall comprise the storage capacities working gas volume, injection capacity and withdrawal capacity in a firm relation as follows:

Hydrogen Storage Epe H2

working gas volume (WGV): 1,900,000 m³ injection capacity (IC): 2,500 m³/h withdrawal capacity (WC): 2,500 m³/h

1.2 The storage customer may book at least one (1) or more storage bundles.



- (2) Firm unbundled storage capacities
 - 2.1 Within the framework of the product "firm unbundled storage capacities", the storage customer may separately contract working gas volume, injection capacity and/or withdrawal capacity.
 - 2.2 The contracting of firm injection and/or withdrawal capacity shall require that the storage customer during the booking period has contracted a firm working gas volume or contracts this volume at the same time while contracting "firm unbundled storage capacities".

III. Interruptible unbundled storage capacities

The product "interruptible unbundled storage capacities" may be interrupted by RGSW both entirely and in part due to operational reasons depending on the utilisation of the firm storage products by storage customers, respectively.

- 1. The injection and/or withdrawal capacity of the product "interruptible unbundled storage capacities" is interrupted due to operational reasons and/or only to the extent necessary to fulfil all firm capacity rights. The injection and/or withdrawal capacity is interrupted pro-rata in relation to the interruptible capacities stipulated by contract.
- 2. The storage customer may contract within the framework of the product "interruptible unbundled storage capacities" injection and/or withdrawal capacity on an interruptible basis.
- 3. The contracting of interruptible injection and/or withdrawal capacity shall require that the storage customer either already contracts firm working gas volume during the booking period or concurrently books firm working gas volume while contracting "interruptible unbundled storage capacities".



B. Storage fees

I. Calculation of the storage fees for firm and interruptible storage products

The storage fee for firm and interruptible storage products is composed of the "fixed storage fee" and a "variable storage fee".

(1) Fixed storage fee

The "fixed storage fee" shall be paid by the storage customer to RGSW for the provision of storage capacities and shall be agreed with the storage customer in the storage contract.

(2) Variable storage fee

The variable storage fee shall be paid by the storage customer to RGSW depending on the actual use of the storage capacities provided. The specific calculation of the variable storage fee shall be agreed with the storage customer in the storage contract.

II. Taxes and duties

Should laws, ordinances, judicial decisions or official measures issued after the conclusion of the contract have the effect of making the production, procurement, transportation, distribution, delivery, storage including the injection and withdrawal of hydrogen more expensive or cheaper for RGSW, the fees shall increase or decrease accordingly from the date on which the increase or decrease in price or costs comes into force or takes effect for RGSW in order to compensate for the price and cost increases or decreases mentioned. This provision applies in particular to the amendment or introduction of taxes (in particular energy tax and CO2 tax), levies, charges, compensation payments, fees or emissions trading.

III. Non-compliance with contract

If in the scope of withdrawal the storage customer has not completely taken over hydrogen volumes previously injected for the storage customer with the same energy content or has not transferred the volumes to one or more other storage customers at the end of the booking period, the (co-)-title of the storage customer to the hydrogen volumes being in the hydrogen storage facility at the end of the booking period shall be pass from the storage customer to RGSW (cf. Section 11.1 of the GTC). These hydrogen quantities shall be remunerated to the storage customer by RGSW at 0.5 times the EEX Green HYDRIX Index for hydrogen per MWh plus the respective applicable taxes and duties for the purchase of the hydrogen
